

> Another topic brought up during the 2007 annual meeting on September 2, 2007 was the current annual meeting date. Traditionally the annual meeting has taken place on Sunday, the day before Labor Day. The discussion was that it might be possible to have larger attendance for the carry in dinner and meeting if the date was moved to either the weekend before or the weekend after Labor Day instead of on Labor Day weekend. This was tabled and will be discussed further at the upcoming annual meeting on August 31, 2008.

> A very notable change is the addition of Siloam Cemetery on the Pike County Genealogical website (http://www.pcgenweb. com/pcgs/index.html). The Pike County Genealogical Society has made available to any cemetery in Pike County, the ability to publish historic and current information about individual cemeteries. We jumped at the chance to be part of this wonderful tool to publish information about Siloam. Currently there's a complete and up-to-date listing of every burial on record for Siloam. This is available to the public without going to the courthouse and researching in person or visiting the cemetery. We have already been contacted by a distant relative of the Wilhoit family who lives in Canada! The website the genealogical society has in place also accepts photographs of each tombstone in addition to the capabilities to add photos of loved ones buried there. We anticipate having a presentation at the 2008 annual meeting to demonstrate just what this means for our cemetery. We would formally like to thank Pike County Genealogical Society for there forsight in creating such a wonderful tool which can be used by area cemeteries.
